




# PLANNING DOCUMENTS

### I. Comprehensive Land Use Plan

- · Outlines long-range goals & objections for community
- · Guides future public & private land development
- Provides continuity & protects public investment
- · Involves community in creating vision
- → Ward's 2013 Comprehensive Plan





#### PLANNING DOCUMENTS

#### 2. Master Street Plan

- Supports city's mobility needs & accommodates all modes of travel
- Guides decisions regarding location, function, design, and classifications of streets
- Includes maps and designs showing the location of current and suggested future streets & potential roadway designs
- · Can be enhanced with Bicycle/Pedestrian/Park Plan
- → Included in Ward's 2013 Comprehensive Plan






# PLANNING DOCUMENTS

### 3. Zoning Ordinance

- Regulates use of property to provide stability & quality of life
- Designates uses within city; Ex: residential, commercial, industrial, open space, and/or mixed-use districts
- Preserves desirable characteristics of each type of setting through lot coverage, building dimensions/ features, parking, signage & landscaping

→ Ward's ZO adopted in 1995; Form-Based Code District adopted in 2013 & amended to voluntary Overlay District in 2020





# PLANNING DOCUMENTS

#### 4. Subdivision & Land Development Ordinance

- Regulates divisions or platting of a tract or parcel of land into one or more lots for the purpose of sale or building development
- · Establishes rules for the creation of lots, blocks, streets & sidewalks
- Provides for easements, parks, and public rights-of-way to protect community connectivity
- → Ward's Subdivision Ordinance adopted in 1995; sidewalk amendment in 2019



### MODEL CODES

#### **Benefits**

- · Simplify & consolidate existing codes, incl. amendments
- · Realize community vision & priorities
- Regional consistency & predictability for developers
- · Balance between livability & economic development
- May include Land Use Plan, Master Street Plan, Zoning & Subdivision Ordinances as needed
