**SECTION 1 – AWARD:** That Hawkins Enterprises, Inc be awarded the contract to widen and overlay Industrial Drive for an amount not to exceed \$79,983.58 except as noted in Section 3 and authorizes the Mayor or City Clerk to sign any and all documents to execute same.

**SECTION 2 – FUNDING SOURCE:** The use of Street Department Funds is hereby approved and appropriated to complete the project and the respective budget amended thereto.

**SECTION 3 – EXCESS FUNDING:** That additional funds not to exceed 10% of the bid amount if needed for unforeseen cost overruns are hereby authorized and appropriated.
