A RESOLUTION AUTHORIZING THE MAYOR TO EXPEND APPROPRIATED FUNDS FOR TO COVER CONSTRUCTION COST SHORTFALLS OF THE NEW LONOKE COUNTY CONSOLIDATED 911 COMMUNICATIONS CENTER

WHEREAS, IN OCTOBER 2023, THE GOVERNING BODY OF THE CITY OF WARD, authorized the Mayor to enter into an Interlocal Agreement for the consolidation of the county's Public Safety Answering Points ("PSAPs") into one 911 Communications Center ("Center") per mandate by the State of Arkansas 911 Board; and,

WHEREAS, contained within the Interlocal Agreement are procedures to cover any financial shortfalls with the Center and the City of Ward budgeted \$75,000 in the 2024 budget to cover such shortfalls; and,

WHEREAS, as determined by the Lonoke County 911 Governing Board, a shortfall in the funds needed for the construction of the Center for 2024 will occur and that each city must remit the amount show on the attached breakdown per the Interlocal Agreement and that said funds be transferred to the Lonoke County 911 Fund per instructions from the Lonoke County Treasurer.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS, HEREBY DECLARES;

SECTION 1 – AUTHORIZATION: That the Mayor and/or City Clerk is hereby authorized to remit to the Lonoke County Treasurer an amount not to exceed \$61,325.41¹.

SECTION 2 – FUNDING SOURCE: That funding for this shall be City of Ward General funds per the 2024 budget.
