**A RESOLUTION AUTHORIZING THE MAYOR AND/OR CITY CLERK TO ENTER INTO A CONTACT WITH UTILITY ASSOCIATES, INC FOR ADDITIONAL CAMERAS FOR THE POLICE DEPARTMENT**

**WHEREAS, IN APRIL 2025, THE GOVERNING BODY OF THE CITY OF WARD** authorized the Mayor and/or City Clerk to enter into an agreement with Utility Associates to provide Body-Worn and In-Car Cameras and associated software for the Police Department; and,

**WHEREAS,** there comes a need to install compatible cameras in the Police Departments Interview Room and Breathalyzer Room that will be tied directly into the current software system.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF WARD, ARKANSAS, HEREBY DECLARES THAT:**

**SECTION 1 – AUTHORIZATION:** The Mayor and/or City Clerk is authorized to enter into a five (5)-year contract with Utility Associates for the purchase/installation of four (4) cameras; two (2) for the Interview Room and two (2) for the Breathalyzer Room as quoted on the attached.

**SECTION 2 – FUNDING SOURCE:** The use of Police Department Operational and/or Reserve Funds is hereby approved and appropriated to complete the project and the respective budgets are amended thereto.

**SECTION 3 – BID WAIVER:** Because of the necessity to utilize the same camera system that ties directly into the existing software system, the need to obtain additional quotes and/or bids is hereby waived.




